Commodore's Corner

Don Anderson

Greetings fellow Renegaders and ice boat enthusiasts. Another winter of fun on the ice is almost upon us and I don't know about you but this is my favorite time of the year. Judging by the sudden surge of early December arctic air, it appears we may be on the brink of an old fashioned cold and nasty winter here in southern Wisconsin.

As Commodore, I consider it an honor to head an organization that has been such a significant part of iceboating history. Elmer Millenbach's 60 years old vision has withstood the test of time very well. There are many things about our fleet that still make it very appealing. One is the constancy of the Renegade class. People like the fact that they will not have to sink hundreds, if not thousands of dollars every year just to stay competitive with boat builders who are on the cutting edge of the sport. In a Renegade, once you have a decent boat, you can remain competitive for many years or even decades. Consider Toledo Ice Yacht Club skipper Les Lashaway at last year's IRIYA regatta in

Toledo. He was close to winning a couple of races with his forty plus year-old boat. Other than a stern-steerer, in how many other fleets would this be possible? The boat that I currently compete with is another great example of a low cost, high performance machine. Charlie Miller tried for the longest time to sell it for a bargain basement price when I was finally talked into buying it. With some Bill Mattison massaging, Greg Simon tuning, and Jim Gluek sail making, I was able to win a couple of regattas in a relative short time. How many other Renegades are out there sitting in someone's barn just waiting for a little TLC to propel it to the front of the fleet? Another attractive quality is the stability of the boat itself. When the wind is blowing, our boats don't have the feel of a wild beast ready to bite at any moment. In a strong wind the Renegade is very smooth and sure with excellent steering and a secure platform. What's not to like about a class that offers all this? Currently there are several skippers I know of that have expressed interest in making the jump to the

Renegade fleet. I think a forty boat regatta is not out of the question in the near future.

The end of the 2007 marks the end of Archie Call's term on the technical committee. When the board of directors considered possibilities for the next technical committee member, there was one appointee that stood out. After polling the board members, it was unanimously decided we appoint Jim Nordhaus to take Archie's place on the committee. In 2007, there is not another person in our class that has put more Renegades on the starting line than Jim. He has opened his shop and offered his expertise to countless sailors from all walks of the iceboating world. Without Jim, the Renegade class in the Madison area would be a fraction of what it is today. I'm sure Jim will do an excellent job and his knowledge of boat building will substantially raise the bar for our class. Here's to a Merry Christmas, a Happy New Year, and I hope all of you are anticipating the upcoming iceboat season with as much enthusiasm as I am.

2008 Notice of Race

- The IRIYA is normally held in conjunction with the ISA regatta. Once again, it is likely the IRIYA regatta will be held independently of the ISA regatta.
- All races will be sailed under the rules of the National Iceboat Authority and those of the International Renegade Ice Yacht Association.
- The regatta will be scheduled on January 4, 5 and 6, 2008. The first race will be held at 10:00 AM (local time) on Friday, January 4, 2008. In the event the IRIYA regatta is postponed, the IRIYA regatta will not be scheduled on the same weekend as the Northwest Ice Yacht Association (NIYA) regatta. The NIYA regatta will take precedence.
- Awards shall be given to the yachts placing first through eighth.
- Entry fee is \$15.00 per yacht payable upon registration.
- Registration will be at regatta headquarters from 8:30 AM to 9:30 AM (local time) on Friday, January 4, 2008
- **Five** (5) races are scheduled and **three** (3) are necessary to complete the regatta. If the IRIYA regatta is held separately from the ISA regatta, there will be **seven** (7) races scheduled and **four** (4) races are necessary to complete the regatta.
- Skippers may obtain sailing instructions at the time of registration.
- For confirmation of the regatta dates, the primary source of information will be the IRIYA web site (www.iceboat.org/renegade.htm) beginning at 1:00 PM CST on December 30, 2007. For final confirmation go to website after 1:00 PM CST on January 2, 2008. If computer access is unavailable, the secondary source of information will be the Renegade Hotline number (641-715-3800, Ext. 8425832) beginning at 1:00 PM CST on December 30, 2007. Information as to the site, headquarters, and accommodations will be available at 1:00 PM CST on January 2, 2008. Members of the Race Committee can also provide regatta information. Minutes of 2007 IRIYA Annual Meeting

Toledo, OH: Comfort Inn & Suites

1. Meeting called to order by Vice Commodore Don Anderson at 5:15 pm.
2. Roll Call: Jerry Simon, Greg Simon, Don Anderson, Ken Norton, Glenn Betzoldt, Ron Rosten, Doug Kolner, Archie Call, Greg Whitehorse, Jon Lofgren.
3. Financial Report unanimously approved as mailed in December 2006. Motion/second – Doug Kolner/Jerry Simon.
4. Minutes from previous meeting were approved. Motion/second – Greg Whitehorse/Jerry Simon.
5. Unfinished Business: None
6. New Business:

6.2. From Tim McCormick: Article IX, Section 1:

Change: "Each existing Board member will move up in rank and the Past Commodore from the previous year will drop off after the completion of that year's annual regatta. (Or, if the annual regatta was not completed that year, as of May 1st of the year in which the annual meeting was held) "

To: "Each existing Board member will move up in rank and the Past Commodore from the previous year will drop off as of May 1st of the year in which the annual meeting was held."

Rationale: This allows the Board to stay intact during the entire winter sailing season. For example, if the annual regatta is held in early January, it would make sense for the Board to handle any remaining issues for that sailing season, rather than hand over the management of the association to a new Board mid-season. Motion/Second Greg Whitehorse/Archie Call. Motion passes unanimously.

A sailor's worst race finish, including DNC, DNF, DSQ, and RAF is eligible for throw-out. After discussing motion, the general feeling was: a. that it was too hard to get races in with no throw-outs. b. There should be consequences for poor race preparation. c. Throw-outs favor the top sailors. Motion defeated 10-0.

6.6 From Tim McCormick - Article XV, Scoring:

Add:

- DNS, DNF, and DSQ shall score points equal to one more than the number of yachts competing.
- For scoring purposes only, the finish position of a yacht being disqualified will be filled by moving the other yachts up.
- Added yachts will readjust the previous day's fleet size for scoring purposes. Motion/Second Greg Whitehorse/Ken Norton. Motion defeated 10-0.

6.7 From Tim McCormick - Add to Sailing Instructions:

Starting Positions: Starting positions for a yacht for the first race shall be determined by random drawing conducted by the Race Committee or designee. Starting positions thereafter shall be by the yacht's finishing position in the previous race. The finish position of a yacht being disqualified will not be filled by moving the other yachts up.

Last Day Time: If the minimum number of races to complete the regatta has been achieved, no race shall start after 1:00 PM, local time. Motion/Second Ken Norton/Doug Kolner. Motion passes unanimously.

6.8 From Ron Rosten - Article XIII

Add: Section 13. The race committee may move the regatta site if it becomes unsafe or conditions change enough to prevent the completion of the IRIYA Championship regatta. If the regatta site is moved, all yachts concerned shall be notified as to the date, time, and place of the next race. The race committee is advised not to make participants travel through dangerous weather conditions to reach the new site. Motion was withdrawn and will be resubmitted at a later date.

6.9 From Jim Hopkins - Article XIII,

Add: Section 13. Renegade skippers 70 years old and older shall be allowed one additional block on their booms. In addition, the aft most block on the rear deck shall be a block with a becket to facilitate main sheet tie-off. Motion/Second Greg Simon/Jerry Simon Motion defeated 1-9

6.10 From Mike Derusha - Article XIII, Section 6:

Add: If 5 or less races are completed, no throw-outs are allowed. If 6 or more races are completed, then 1 throw-out is allowed. A sailor's worst race finish, including DNC, DNF, DSQ, and RAF is eligible for throw-out. Motion/Second Greg Whitehorse/ Ken Norton. Motion defeated 10-0.

7. Election of officers for the following year. From the Nominating Committee: Glenn Betzold to be appointed the 1st year Director, Dan Hern to be appointed the 2nd year Director. Ron Rosten will continue as Secretary/Treasurer for 1 more year. Don Anderson will advance to the position of Commodore and Tim McCormick will become Past Commodore. Motion/second - Ken Norton/Greg Whitehorse. Motion passes unanimously

Rationale: We should discourage the need to carry battens out to the race area for between race changes. See what equipment changes have done to the DN's. Choosing the equipment to use for the entire regatta racing will enable a bigger variety of winners who make better choices. Add a new section: Section 13: Any skipper 70 years or older can use one additions sheet rope block.
