Commodore's Corner

My introduction to the sport of iceboating was not exactly what you would call a positive one. Much to the dismay of the rest of the family, my father spent his winter nights working on his iceboat in our basement. Because of his efforts, our family television became an unwatchable whiteout of snow and the sound of his ear-piercing power tools was often our bedtime lullaby music. Even though those unpleasant nights were deeply disturbing to the rest of the family, my dad's passion for the sport could not be deterred by our frequent foot pounding and never-ending pleas to stop the insanity; man, talk about grating on the nerves. Remembering these nights seems funny to me now, but at the time I didn't understand the fun that would come out of that nonsense.

I grew up on Green Bay in Marinette, WI near a place the locals call the Menekaunee Flats. Ice boating in this area played a very big part in my upbringing. The boat that gave me my first taste of ice boating was an old stern steer. The boat was always parked at the Flats back when ice was ice, long before our winters began their current warming trend. This old stern steer used a baseball bat as a tiller, and the tiller wasn't the least bit shy about kicking us out of the cockpit the instant it would hit a crack or something rough on the ice. Getting thrown from

the boat happened very quickly. I don't remember much of the flying through air part of it but I do remember how often I'd slide across the ice and prey that a snow drift would stop me. My brother and I also had a small boat that my dad made from a set of plans he found in a Popular Science magazine. All we had to do was carry the sail down to the Flats, set it up, and off we'd go. I am sure we never broke 15 knots in a stiff wind with this boat. But given our age, the boat's lack of steering, and having to lie on our stomachs with our eyes shaking 6" above the ice, it seemed like a rocket ship to us.

My dad has racing in his blood. It's so bad that my mother spent her wedding night watching him race his 37 Ford stock car in Escanaba, MI; how is that for romantic? Once my father saw his first Renegade, he was hooked. He had to race it in the worst way. He built a boat in just a few months and had it ready for the upcoming season. After my father started racing his Renegade, it opened up a whole new world of iceboating. How did he place in the Renegade Nationals, the ISA and the Northwest? What were the conditions? Who was fast? I loved attending the club meetings in Roger Derusha's basement and learning the rules of racing.

Close to 25 years passed before I would start to ice boat again. My dad built his second Renegade and he asked if I would like to run his first boat. This lead to one of my fondest memories; I sailed on Lake Noquebay along side a Bald Eagle in flight, riding the same wind. Now my memories are filled with all the great times with the skippers I meet at the yachting events with my dad. Looking back, I'm glad we were unable to discourage my dad's passion for iceboating.

IRIYA Championship Regatta

2009 Notice of Race

The IRIYA is normally held in conjunction with the ISA regatta. Once again, it is likely the IRIYA regatta will be held independently of the ISA regatta.

All races will be sailed under the rules of the National Iceboat Authority and those of the International Renegade Ice Yacht Association.

The regatta will be scheduled on January 2, 3 and 4, 2009. The first race will be held at 10:00 AM (local time) on Friday, January 2, 2009. In the event the IRIYA regatta is postponed, the IRIYA regatta will not be scheduled on the same weekend as the Northwest Ice Yacht Association (NIYA) regatta. The NIYA regatta will take precedence.

Awards shall be given to the yachts placing first through eighth.

Entry fee is \$15.00 per yacht payable upon registration.

Registration will be at regatta headquarters from 8:30 AM to 9:30 AM (local time) on Friday, January 2, 2009

Five (5) races are scheduled and **three** (3) are necessary to complete the regatta. If the IRIYA regatta is held separately from the ISA regatta, there will be **seven** (7) races scheduled and **four** (4) races are necessary to complete the regatta.

Skippers may obtain sailing instructions at the time of registration.

For confirmation of the regatta dates, the primary source of information will be the IRIYA web site (www.iceboat.org/renegade.html) beginning at 1:00 PM CST on December 28, 2008. For final confirmation go to website after 1:00 PM CST on December 31, 2008. If computer access is unavailable, the secondary source of information will be the Renegade Hotline number (608-204-9876) beginning at 1:00 PM CST on December 28, 2008. Information as to the site, headquarters, and accommodations will be available at 1:00 PM CST on December 31. Members of the Race Committee can also provide regatta information. Minutes of 2008 IRIYA Annual Meeting

March 9, 2008 Fontana, WI - Geneva Yacht Club

Meeting called to order by Vice Commodore Jim LaFortune at 7:10 pm.

Roll Call: Jerry Simon, Greg Simon, Ken Norton, Glenn Betzoldt, Ron Rosten, Doug Kolner, Archie Call, Greg Whitehorse, Jim LaFortune, Robert Pagel, Michael Disbrow, Harley Disbrow, John Lamont.

Financial Report unanimously approved as mailed in December 2007. Motion/second - Doug Kolner/Jerry Simon.

New Business:

By-Laws, Article XIII Races, Section 13.7:

Omit the words "or sail battens"

Discussion: Robert Pagel states that the plans do not specifically call for more than one set of battens. Arlyn LaFortune mentioned that Elmer Millenbach was a big proponent of batten change and would be against this amendment. Mike Derusha spoke about potential safety concerns if a skipper would not be allowed to flatten the top of his sail with stiffer battens; especially if they were caught with a full sail in windy conditions. (m/s: J. Simon/K. Norton) Motion defeated.

By-Laws, Article XIII Races:

Add a new section: Section 13.13: Any skipper 70 years or older can use one additions sheet rope block.

Discussion: After lengthy discussion about this proposal it was clear this proposal did not have the support needed to pass. But the majority in attendance agreed if a senior skipper felt he needed an extra block in order to compete, no one would object if he were to add one. (m/s: J. Simon/G. Whitehorse) Motion defeated.

Motion by T. McCormick, no second. Defeated.

6.7 Article XIV, Scoring, Computation of Points:

Add:

- -DNS, DNF, and DSQ shall score points equal to one more than the number of yachts competing.
- -For scoring purposes only, the finish position of a yacht being disqualified will be filled by moving the other yachts up.

-Added yachts will readjust the previous day's fleet size for scoring purposes.

Article XIII - Races, Section 13.4

Add:

The length of each race shall be a minimum of 8 miles. It is preferable for a race course to be one mile between the windward and leeward marks and for each race to be 4 laps. The distance between marks may vary provided the length of the race is 8 miles or greater.

Discussion: Greg Simon stated he was not in favor of this proposal because he felt we were better served by remaining flexible. Mike Derusha thought we would be better served by nailing this down now and setting a minimum distance to complete a championship regatta race.

Starting positions for a yacht for **all** races shall be determined by random drawing conducted by the Race Committee or designee

- a. All skippers will know where to line up after every race without having to go to the safety zone posting or bother the judges.
- b. Reduces the concentration of boats just outside the safety zone.
- c. A piece of masking tape with starting positions could be easily attached to the deck or cockpit of the competing boat
- d. This would improve the efficiency of boats getting to the line for the next race.
- e. This reduces the advantage of the faster boats always getting the best starting positions.
- f. This would make it much easier and efficient for the scorers on the ice.
- g. We roll the dice for the first race why not do it for the rest of the races?

Early in October, IRIYA Secretary/Treasurer, Ron Rosten, called and asked me if I would be interested in "writing something" for the newsletter that you're now holding in your hand. As I well know, one of the Renegade Association's duties of the Secretary/Treasurer is producing the organizations newsletter and it sure is nice when others contribute to it in order to make it...how should I word this?...more filled out. I asked Ron if he had any particular subject matter in mind and he informed me "nope", anything I wanted to write. I started a draft that dealt with my concerns of how high gas prices and a weak economy would affect our Renegade regattas, but that just got depressing. I crumpled up the paper it was written on and tossed it toward the circular file in the corner of the room (I missed). Determined to come up with something a bit more up-beat I decided to cover a little Renegade news from around here since last winter. Down at Doug Kolner's Belle Isle Boat Works (Monona, WI), Doug and I spent many hours working on various iceboat projects the past few months. Local DN sailor Jamie Hanson, son of Bill Hanson who steered the "Fat Chance" Class E skeeters throughout the 80's and 90's. dropped off a slew of partially finished Renegade parts in hopes we could get this package on the ice this winter. We built chocks, runners, a boom, and lots of hardware for the mast, springboard and runner plank before Jamie dropped off the fuselage. Unlike the other wood parts that were more of a "just make up the hardware" project, the hull was very incomplete when brought in to the shop. It needed steering gear, pedals, mounting hardware, along with the top and bottom decks glued on. It was quite a job, but by late August the hull was finished complete with paint, pinstripe, and name "Melissa Ann" lettered on the sides. Other projects at BIBW included finishing Doug's own new DN, what he calls his Wingra boat in hopes that lake will offer up some early season ice again this season. My brother Gary, another ex-skeeter guy, should have his new Renegade, "Donkey Racer" (ask him, not me) on the ice this year and I'm sure he'll be a welcome addition to our

fleet. The current projects at the shop are several sets of new Renegade runners. Although Doug Kolner has spearheaded the new runner effort, with eight sets ordered, three sets will be completed at BIBW (Kolner, Greg, Gary Whitehorse). Other blade sets are going to Jerry and Greg Simon, Ron Rosten, Donny Anderson, and Jim Nordhaus.

Let's see...what else has gone on down at BIBW? We worked some Maggie Fauerbach's DN, made repairs on Doug's trailer, re-shaped my runners and even found time to brew a very well received light ale (Belle Isle Boat Works & Brewery?). As this is being written, we are preparing the boat shop to host the 4LIYC's annual fall picnic. The

floors are being swept (finally), the power tools are being pushed into the corners to make room, and the sandbags along the channel have all been hauled away. Oh...I forgot to mention that BIBW is located about 15 feet below sea level and Kolner spent half the summer battling the "100 year" floods (for the 3rd time in five years) that plagued south central Wisconsin earlier this year.

With all this activity around here you'd think I'd be all set for the season to begin. I wish. I still have a trailer that needs repair, runner chocks that I want to re-work and I need to paint my boom. Well, that's about it from these parts. If we're. lucky, gas will drop and allow us to travel this winter. Hope to see you all on the ice!
