Commodore's Corner

Fellow Renegaders, how lucky we are, us ice boaters. Winter is coming on and we are excited, while most sane people dread the prospect of winter, many are even making plans to head south to get away from it altogether.

For the last two seasons I have been fast and lucky enough to win the Senior trophy. You have to be 60 before you can even think about taking this one home, and then you have to get up and go to the regatta, and then you have to beat the other old farts, the likes of Jerry Simon, Archie Call, Jim Nordhaus and anyone else who is sailing ice in their Golden years.

We have to face it, there is no way in hell that any of us old farts are going to win the IRIYA Championship, so the Senior Trophy is it for us, it's our Championship. (Well, on second thought, there is a chance that Jerry could win the big one again. You know he builds the parts for Greg's boat, and we have on occasion (the last Toledo regatta) seen those parts fail and it paid off for Jerry.) But I digress.

If you haven't taken a look at this trophy, it's a beauty. It started out in 1925, as the Detroit Perpetual Ice Boat Trophy honoring Commodore George Marsh. From 1925 to 1936, it was the Stern Steerer trophy for boats with names like Zip, Elandor

and Mischief, whose owners were respectively George Champine, Ralph Buchman and John Warren.

Then in 1936, Detroit built a new iceboat fleet called the DN 60 when The Detroit News opened up their workshop and 12 boats were made. Let's race! By 1938, the Garwood Regatta was started, and our Senior Trophy was the new DN Fleet Championship Trophy. It has all the names of the winners-Warren Dowling, Maurice Robinson, Howard McDougall and Walter Kalz. These winners' names from 1925 until 1947, are just names of guys like us, goodlooking and wearing funny clothes. I tried to see if I

could find some information about them, but I had no luck as all their buddies have sailed on.

But after 1947, there are the two names that we all know, Bill Sarns and Skip Boston. They dominated the DN Fleet in the Garwood Regattas. For some unknown reason, 37 years went by with the trophy collecting dust somewhere. Then Detroit sailor Loren Sherry re-donated the trophy to the IRIYA with a deed of gift to the highest placing skipper over sixty in the championship regatta.

The first Renegader to take her home was Jack Ripp in 1997. Then the Menekunee boys, Roger Derusha and Arlyn Lafortune, got their turn. Jerry Simon took her to Madison for three years before I took her back home to Michigan where it all started.

I'm sorry that Loren didn't get his name on it before he retired his Renegade, but perhaps it's not too late. The Sherry's have a new generation of ice boaters coming up, and maybe if the weather cards get played right, he could have a crew to help him in a Lake St. Clair Regatta.

So now you have something even more to look forward to than winter, you can look forward to becoming a GIT --that's an "old geeser in training" and a chance at winning the Senior Trophy. Let's Have a Fun and Safe Season.

IRIYA Championship Regatta

2010 Notice of Race

The IRIYA is frequently held in conjunction with the ISA regatta. Once again, it is possible the IRIYA regatta will be held independently of the ISA regatta.

All races will be sailed under the rules of the National Iceboat Authority and those of the International Renegade Ice Yacht Association.

The regatta will be scheduled on January 8, 9 and 10, 2010. The first race will be held at 10:00 AM (local time) on Friday, January 8, 2009. In the event the IRIYA regatta is postponed, the IRIYA regatta will not be scheduled on the same weekend as the Northwest Ice Yacht Association (NIYA) regatta. The NIYA regatta will take precedence.

Awards shall be given to the yachts placing first through eighth.

Entry fee is \$15.00 per yacht payable upon registration.

Registration will be at regatta headquarters from 8:30 AM to 9:30 AM (local time) on Friday, January 8, 2009

Five (5) races are scheduled and **three** (3) are necessary to complete the regatta. If the IRIYA regatta is held separately from the ISA regatta, there will be **seven** (7) races scheduled and **four** (4) races are necessary to complete the regatta.

Skippers may obtain sailing instructions at the time of registration.

For confirmation of the regatta dates, the primary source of information will be the IRIYA web site (www.iceboat.org/renegade.html) beginning at 1:00 PM CST on January 3, 2010. For final confirmation go to website after 1:00 PM CST on January 6, 2010. If computer access is unavailable, the secondary source of information will be the Renegade Hotline number (608-204-9876) beginning at 1:00 PM CST on January 3, 2010. Information as to the site, headquarters, and accommodations will be available at 1:00 PM CST on January 6. Members of the Race Committee can also provide regatta information. Minutes from previous meeting were approved. M/S – Jerry Simon/Andy Hopkins.

Financial Report unanimously approved as mailed in December 2008. M/S – Arlyn LaFortune/Andy McCormick Unfinished Business: None

New Business:

6.1 By-Laws, Article XIII, Section 13.5

Change: Starting positions for a yacht for the first race shall be determined by random drawing conducted by the Race Committee or designee. Starting positions

thereafter shall be by the yacht's finishing position in the previous race.

To: Starting positions for a yacht for all races shall be determined by random drawing conducted by the Race Committee or designee. M/S – Jerry Simon/Andy McCormick

Discussion: Jerry was asked how the skippers remember the numbers. His response was they could write it on tape and affix to their cockpit. Mike Derusha stated he definitely preferred maintaining the current system, which was echoed by Greg Simon. Greg McCormick raised the possibility of a skipper drawing a bad number and then deciding it may be in his best interest to saunter down to the favored end of the starting line. Greg Simon and Doug Kolner suggest this idea be tried at a local level before using in a championship regatta. Motion defeated.

6.2 By-Laws, Article X Meeting, Section 10.2

All motions shall be submitted to the class Secretary prior to January 1st of the year in which the annual meeting is held.

Change to: All motions shall be submitted to the class Secretary prior to December 1st of the year before the annual meeting. M/S –

Discussion: After a brief discussion the motion passed unanimously.

6.3 Article XII Voting, Section 12.1

Each member in good standing, in attendance at the annual meeting, shall be entitled to cast one vote, until such time as the majority of members feel the association has grown large enough to have representation by fleet delegates. There shall be no proxy votes.

Change to: Each member in good standing shall be entitled to cast on vote, until such time as the majority of members feel the association has grown large enough to have representation by fleet delegates. Proxy votes will be recorded by the Secretary and verified as being paid at the time the vote was recorded. These votes shall be counted at the annual meeting for each given motion. M/S – Jerry Simon/Greg Simon.

Discussion: Andy Hopkins thought the problem with proxy voting is the voter misses out on the discussion of a meeting, which could influence their vote. Jerry Simon then made a motion to make an amendment to 6.3 and replace proxy with absentee ballot. That amendment was defeated. Glenn Betzoldt brought up the point that the DN class does allow members to send in a ballot through the mail and it has to be an actual person to cast the vote (only one vote per person). Andy Hopkins questioned the wisdom of allowing non participants too much influence on the outcome of the meeting. Motion defeated.

Election of officers for the following year. From the Nominating Committee: Greg Simon to be appointed the 1st year Director, John Lamont to be appointed the 2nd year Director. Ron Rosten will continue as Secretary/Treasurer for 1 more year. Doug Kolner advances to Vice Commodore, and Glenn Betzoldt will advance to the position of Commodore. Jim LaFortune becomes Past Commodore. M/S – Doug Kolner/Jerry Simon. Motion passes unanimously


During the "fateful" race, most of the fleet was in front of us as usual. Racing was very fast with moderate winds and hard ice. I was being lapped and going downwind. Ken was sailing upwind near the upwind mark—dead in front of me on a collision course! I altered my course, and so did Ken—in the same direction. Nothing to worry about as there was still time to correct. And we both did—once again in the same direction. We were approaching each other at 50+mph and we ran out of time for a third correction.

Crash! Our runner planks collided two feet inside the runner chocks. Jim Payton, the official judge who was a mile downwind, said the sharp crack sounded like a cannon blast from his old military days.

Meanwhile, back at the crash, both of our boats had shattered apart. Masts down, hulls on their

side, runner planks skidding alongside hulls—all being held together with a spaghetti mixture of stainless cables. At 50+ mph, boats don't quickly come to a stop on hard ice. All I remember is my head (in the crash helmet) bouncing on the ice forever. I didn't realize until the adrenalin subsided that the entire rear of my hull had remained attached to the plank. This was the tangled mess that had been skidding alongside my bouncing head. How lucky that I didn't lean back as I skidded.

After I finally stopped, I crawled out to see if everything physically worked. I ran over to Ken who was already out of his boat. We hugged each other and fell to the ice in a state of euphoria each knowing the other wasn't seriously hurt.

Then the magic began. Bill Mattison took a look at the carnage and said just bring it over and we will see what can be done to get you back on the ice soon. Monday night after work I delivered the two pieces to Bill's basement on

Sherman Ave. If you know his basement, you know that things were cramped to say the least. He surveyed the damage and said let's fit the splintered pieces back together and scarf on some overlapping wood and test this new Gougeon stuff. The boat was a Weldwood boat.

The next night Bill and Jack went to work fitting things together and did some initial gluing. Jim and I helped by staying out of the way, sweeping the floor and making tools and beer runs. The operation required multiple gluings and Bill would unclamp in the morning before work and be ready to glue again in the evening.

Anyone who has worked around Bill knows he is a man of few words and lots of action. Many times Jim and I were just in the way and relegated to sitting on the stairs watching the sitka sawdust fly.

Four more nights and my boat was whole again! You can imagine everyone's surprise when Simonized appeared back on the ice the following week-end. The natural finished sides were a thing of the past but the boat seemed even faster than when it was new.

I am sure my story of what Bill has meant to ice boating can be told over and over by many sailors.
