## Random Renegade Thoughts

I was in a registration tent at a scow regatta many years ago when I felt a jab in my ribs. "Your runners sharp?" It was Buddy Melges. It's the hottest part of summer and he's got iceboating on his mind. Here I thought it was only me, thinking of the last hot lap of the season. We get so little time in our boats but the rides are soo good. It's a struggle to describe the feeling, and being ready to "surf when the surf's up" is especially important in our sport. To me the message was "you gotta be ready to go!" Words of wisdom from a champ.

Beyond the actual sport of hardwater sailing is the craft itself. Preparing a classic iceboat for competition can be a labor of love. Fortunately I kind of like standing in a cool garage on a hot summer day, sanding on a plank or varnishing a mast. No shop time can be a waste of time. There's always some "hard spot" that needs softening or sharp edge to be rounded... a tinkerer's dream. Bring a different boat to the lake every weekend" is my mantra for finding some speed. So often I leave the ice knowing there's something that needs attention. Effort in the shop really helps you to understand the boat which leads to more speed, more control, more comfort, and better races. And the thing is, everything is something. The mast may be just right, but what about the springboard? Is the platform square? Is the plank a little too crowny? The point is that it's a harmony of parts and not just one thing, it's everything. They say a fast boat is an easy sailing boat. I wish my boat sailed easier but the placebo effect of shop time may be as important as any real effect on speed. Alright, to be perfectly honest, sometimes I just crack a beer and stare at the boat. Nevertheless, time spent with your boat is quality time, but the proof is in the puddin. Ice time is golden time and all the hours of thinking about it can't match the exhilaration of actually doing it.

I checked the water temp in Lake Monona today and it was a cool 42.5 degrees, and the air temp was 45.2 degrees, so there's is still a ways to go. But I can't get too comfortable because the average freeze is less than a month away. I recently found a piece of yellow paper with a barely readable list of boat projects I had written down last April, and maybe half of those projects were completed. It seems there's always something to do, but at least I can say that my runners are sharp.

### **Notice of Race**

### 2012 IRIYA Championship Regatta

The IRIYA is frequently held in conjunction with the ISA regatta. Once again, it is possible the IRIYA regatta will be held independently of the ISA regatta.

All races will be sailed under the rules of the National Iceboat Authority and those of the International Renegade Ice Yacht Association.

The regatta will be scheduled on January 6, 7 and 8, 2012. The first race will be held at 10:00 AM (local time) on Friday, January 6, 2011. In the event the IRIYA regatta is postponed, the IRIYA regatta will not be scheduled on the same weekend as the Northwest Ice Yacht Association (NIYA) regatta. The NIYA regatta will take precedence.

Awards shall be given to the yachts placing first through eighth.

Entry fee is \$15.00 per yacht payable upon registration.

Registration will be at regatta headquarters from 8:30 AM to 9:30 AM (local time) on Friday, January 6, 2011

**Five** (5) races are scheduled and **three** (3) are necessary to complete the regatta. If the IRIYA regatta is held separately from the ISA regatta, there will be **seven** (7) races scheduled and **four** (4) races are necessary to complete the regatta.

Skippers may obtain sailing instructions at the time of registration.

For confirmation of the regatta dates, the primary source of information will be the IRIYA web site (www.iceboat.org/renegade.html) beginning at 1:00 PM CST on January 1, 2012. For final confirmation go to website after 1:00 PM CST on January 4, 2011. If computer access is unavailable, the secondary source of information will be the Renegade Hotline number (608-204-9876) beginning at 1:00 PM CST on January 1, 2012. Information as to the site, headquarters, and accommodations will be available at 1:00 PM CST on January 4. Members of the Race Committee can also provide regatta information. ## 2011 Annual Meeting Minutes

January 7, 2011 Nau-ti-gal Restaurant, Madison, WI

- 1. The 2011 IRIYA annual meeting was called to order at 6:20 PM by Commodore Glen Betzoldt
- 2. Roll call: Glen Betzoldt, Doug Kolner, Rich Eckstein, Greg McCormick, Greg Simon, Don Anderson, Peter Fauerbach, Tim McCormick, Ken Norton, Jerry Simon, Kenneth Kreider, Mike Derusha, Andy Mccormick, Archie Call, Dan Bierman, Jon Lofgren, Laura Otten
- 3. Financial Report unanimously approved as mailed in December 2010. Motion/second Doug Kolner/Jerry Simon.
- 4. Minutes from previous meeting were approved. Motion/second Mike Derusha/Ken Kreider.
- 5. Unfinished Business: None
- 6. New business
  - 6.1 By-Laws, Article XIII, Section 13.7 Delete the words: or sail battens Discussion: Ken Kreider stated battens are very cheap, very minor, and readily available to anybody. Mike Derusha also stated that this adjustment has been allowed since the advent of the boat and questions why we would consider changing this now. Archie Call added that the cost for a set of battens is nothing and we should keep the rule as is. Doug Kolner also said current rules do not put anybody at a disadvantage. Ron Rosten said inserting thicker battens in a sail and backing them out a bit during a blow is a quick and easy and stabilizes the boat. If making this adjustment was banned, all I'd have to do is snap my battens in 2 and notify the chief judge that I'm fixing a broken part. Why go down this route? Tim andAndy McCormick both stated they were in favor of the motion. (m/s: T. McCormick/A. McCormick) **Motion defeated 9-4.**
  - 6.2 By-Laws, Article XII, Section 12.1 Change: Each member in good standing, in attendance at the annual meeting, shall be entitled to cast one vote, until such time as the majority of members feel the association has grown large enough to have representation by fleet delegates. There shall be no proxy votes. To: Each member in good standing shall be entitled to cast a vote on each printed motion as published in the newsletter by attending the annual meeting or by absentee ballot, using either mail, or e-mail before the annual meeting. The votes shall be counted by the secretary and becomes part of the vote tally to determine if the motion passed or fails. There shall be no proxy votes. Discussion: Doug Kolner stated that if this motion passes, the will of the fleet will be dictated by non-participants. Greg Simon and Ken Kreider both recalled how the Skeeter Ice Boat Club would dominate the ISA meeting agenda with their large numbers of non active members. Dan Bierman added that this is standard operating procedure for the DN Association and thinks it's a great idea. (m/s: D. Kolner/P. Fauerbach) **Motion defeated 12-3.**
  - 6.3 By-Laws, Article XIII, Section 13.6 Change: (current 7 race regatta format) so that 4 races can be completed on Sunday in the event there is no racing on Friday and Saturday. Also in the motion is the amendment that no races shall be started after 1:00 PM local time if the minimum number of races has been achieved. Discussion: Very limited discussion with everybody in agreement. (m/s: D. Kolner/G. Betzoldt) **Motion passes unanimously.**

- 6.4 Discussion Item #1-Andy McCormick brought up the fact that current IRIYA rules allow composites to be used for repairs and reinforcement. The problem with this is there are those that are taking advantage of a loose interpretation of current rules, especially when it comes to Renegade masts that are starting to bend like a composite DN mast. Andy wants to see something proposed that eliminates any grey areas of the rules. Greg Simon suggested that a small section of the mast be left unpainted near the spreader to prove the mast is free from composite materials.
- 6.5 Discussion Item #2-Race Committee Chair Ken Norton wanted to bring up the fact that there is a serious problem with some skippers running their booms too close to the deck. Ken felt this was causing serious blind spots and it was only a matter of time until it was going to bite someone hard.
- 6.6 Discussion Item #3-Mike Derusha asked what the group thought of a 2 day-5 race Renegade Championship regatta in December if the previous year's regatta had not been completed. Mike felt that if we ever were able to sail the regatta under current rules, turnout would be low due to holiday commitments and a reluctance to take days off in December when the next year's regatta is just a few weeks away.
- 6.7 Discussion Item #4- Jerry Simon wanted to know if the group was interested in presenting beer steins to all regatta participants as had been done in the past. Commodore Glen Betzoldt raised his beer, proclaimed it a fantastic idea, and ordered the project be funded immediately provided somebody make a motion to adjourn the meeting after the election of officers for the following year.
- 7. Election of officers for the following year From the Nominating Committee: Greg McCormick to be appointed the 1st year Director, Greg Simon to be appointed the 2nd year Director. Ron Rosten will continue as Secretary/Treasurer. John Lamont will advance to the position of Vice Commodore, Doug Kolner will advance to the position of Commodore and Glen Betzoldt will become Past Commodore. (m/s Ken Kessler/Ken Kreider. Motion carries.
- 8. Motion for adjournment (m/s Ken Kessler/Ken Kreider. Motion carries. Meeting adjourns at 7:40.

Boom height measurement on the mast will be a distinct 3/4 inch line (preferable black electrical tape) placed perpendicular to the center line around the mast 15 inches above the bottom of the mast cup. The boom goose neck shall not be allowed to go below this mark while under maximum sheet rope tension either in the pits or on the race course, resulting in a disqualification.

6.2 Article XII Races Section 13.6

**Add:** If IRIYA Annual Regatta is not completed during the normal winter months, the regatta may be completed the following November or December with an additional race format option. If it's necessary to sanction a November or December regatta, a 2 day, Saturday-Sunday, 5 race regatta will be allowed. The regatta format would be at the discretion of the race committee. A 2 day, 5 race regatta must have 3 races completed in order for the regatta to count and the format would be as follows:

<u>Day</u>	Scheduled Number of Races	Maximum Number of Races
Saturday	three	three
Sunday	two	three

This format is only an option if the IRIYA Annual regatta is scheduled in November or December. It is still possible for the race committee to sanction a 3 day, 7 race regatta separate from the ISA, or a 3 day, 5 race regatta in cooperation with the ISA in November or December. If a fall regatta is needed, and the conditions are favorable, it's up to the race committee to determine the format. Rationale: Even though we have had the option of a December regatta for years, we've yet to ever sanction one. If the conditions ever were right for a December regatta, it's always a very busy time of year. There are the holidays and other year end activities, and vacation time is usually about used up for most. By squeezing it down to a 2 day event, I believe it would improve the chances of the regatta taking place and would increase the turnout.

### The Safety Dilemma of a Low Boom

Most of us see the inherent problem of sailing with our booms so low that they block our view from one side of our boats. The boom resting on the shoulder of the skipper sitting deep inside the cockpit creates dangerous collision-causing situations, especially on a short course with lots of competitive sailors.

The advantage of the low boom is obvious—our boats are faster. The center of gravity/effort keeps the boat from hiking by producing lower mast bend and flattening the sail to handle windier conditions.

How do we accomplish a fair playing field so that all sailors have better visibility and safer sailing experiences while sacrificing only a minimal degree of speed advantage. Several ideas have surfaced. Preventing the boom from the extreme lower position can be accomplished by placing a stop/lock on the gooseneck track a set number of inches

(approximately 15) above the mast butt. This might be hard to make and once attached, it has to be removable when derigging. Another idea is to cut off the existing gooseneck track so we all sail with the track no closer than 15 inches from the butt of the mast. Elmer's design/plans show the distance to be 9 inches. This is a great idea for ease of policing as the slide would come off the track if the skipper tried to sail with a very low boom by sheeting super hard and/or setting low boom halyard. You would be altering Elmer's plans, a no-no in my mind, and would require all serious racers to modify their current boats. This amounts to removing their tracts and hack sawing off the necessary material so as to comply with the new distance measurement.

Another idea would be to require a simple tape line mark perpendicu-

lar to the mast's center line at a specified distance, approximately 15 inches from the butt. The skipper is now responsible to adjust the halyard so the sail would not go below the mark even under maximum sheet pressure. Other sailors could see if their competitors were complying even on the race course and pit area before or after races. This becomes a measure of the true sportsmanship of each competitor.

Having raced Renegades a long time, I have found that the remarks following collisions I've observed are mostly "I didn't see the other boat before we collided." This generally occurs when port boats are unable to see starboard boats. We need some official action on this most important matter dealing with the future of safe Renegade sailing.
