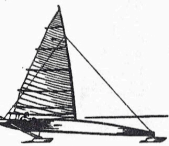

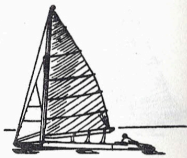

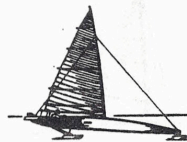

NEW BUSINESS
